## FEDERAL DIRECT STAFFORD LOAN APPLICATION For First-time Borrowers

Federal regulations require colleges to confirm a student's eligibility for federal aid, before we can process the Federal Direct Stafford Loan. If you haven't already, you must complete the Free Application for Federal Student Aid (FAFSA) at [www.fafsa.ed.gov](http://www.fafsa.ed.gov), You will need the Department of Education PIN you use to file the FAFSA to complete the online requirements for your loan. The following **three** requirements are your part of completing the process to borrow the Federal Direct Stafford Loan.

- 1) Complete and submit this Application form to the Financial Aid Office
- 2) Complete the "Entrance Counseling Session for the Federal Direct Stafford Loan" online
- 3) Complete the Master Promissory Note (MPN) for the Federal Direct Stafford Loan online

(Contact the Financial Aid Office if you are not able to complete these requirements online.)

### ENTRANCE COUNSELING SESSION for the FEDERAL DIRECT STAFFORD LOAN

All students who are borrowing for the first time at Colorado College are required to complete an Entrance Counseling Session. This is a federal requirement to help you understand your rights and responsibilities as a borrower. Go to the Colorado College website [www.ColoradoCollege.edu/financialaid/counseling](http://www.ColoradoCollege.edu/financialaid/counseling) and click on "Entrance Counseling Session for Federal Direct Stafford Loans." You must complete this counseling session before the first disbursement of your loan can be credited to your student account.

### MASTER PROMISSORY NOTE for the FEDERAL DIRECT STAFFORD LOAN

To complete the application process for the Federal Direct Stafford Loan, you must complete a Master Promissory Note (MPN) at <https://dlenote.ed.gov/empn/index.jsp>. The MPN is the legal agreement that you will repay your loan in the future. You will only be required to complete one MPN while attending CC. The MPN process will require you to enter your Department of Education PIN that you used to do the FAFSA.
