AmeriCorps Service Education Award

Are you employed in an off-campus **community service** work-study job?

Do you **volunteer** in the community on a regular basis?

Are you involved in a **service-learning** class or planning an unpaid internship?

Then YOU might be eligible for an AmeriCorps **Service Education Award!**

- ⌘ AmeriCorps education awards are awarded based on what you do in the community, not on financial need or GPA. If you're planning to do unpaid service at a non-profit organization, you could qualify.
- ⌘ The education award is a great fit for off-campus community service jobs, internships, practicum experiences, fieldwork experiences, alternative spring break participation, ongoing and committed volunteer work, and service learning classes.
- ⌘ You can use your education award to pay for tuition, make payments on existing loans, or save it for up to seven years for graduate school, or continuing education in the future.

300 hrs of service in a calendar year = \$1,000

450 hrs of service in a calendar year = \$1,250

900 hrs of service in 2 calendar years = \$2,363

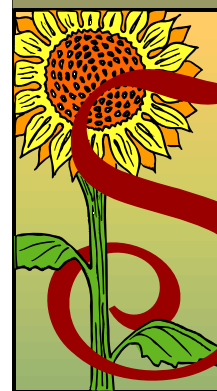
Off-Campus Work Study

McHugh Leadership Fund

The Purpose of The Center for Service and Learning's McHugh Leadership Fund is to develop, support, and advance leadership within the realm of community service.*

Proposals for the McHugh Leadership Fund:

- ⌘ Should be directed to the Director of the Center for Service and Learning.
- ⌘ Should be submitted electronically.
- ⌘ Should provide an avenue to share your experience with the Colorado College community, e.g. campus workshop, video presentation, photo documentary, etc. upon completion.
- ⌘ Should include the following:
 - > Describe and give dates of program/event for which you are requesting funding, explain why this funding source is an appropriate source for your request (how does your request, develop, support, or advance community service leadership).
 - > Amount of funding requested.
 - > Outline of proposed budget for program (multiple funding sources are encouraged for large requested).

All recipients of the McHugh Leadership Funds are expected to:

- ⌘ Write a Thank-You letter to the benefactors of this fund, Jerry and Anabel McHugh.
- ⌘ Attend a dinner during Block VIII with Jerry and Anabel McHugh.
- ⌘ Meet with Director of the Center for Service and Learning for planning follow-up after completion of program or event for which the funding was granted.
- ⌘ Acknowledge the McHugh Leadership Fund in all publicity.
- ⌘ Include the Center for Service and Learning in the distribution of publicity associated with the funding request.
- ⌘ If you are applying for McHugh Leadership funds to travel abroad for an independent service projects you must comply with the guidelines for such travel at <http://www.coloradocollege.edu/international/documents/logistical%20review.pdf> and <http://www.coloradocollege.edu/servicelearn/InternationalService/> prior to release of funds.

Special Projects Fund

The Purpose of The Center for Service and Learning's Special Projects Funds are:

1. To sponsor one-time presentations and events that educate, inform and/or support the mission of the Center for Service and Learning.
2. To provide financial support for new community service initiatives until regular funding can be secured.
3. To assist established service initiatives to meet special and/or emergency funding needs (evidence of other efforts must be documented).

All proposals for Special Project funds:

- ⌘ Should be directed to the Director of the Center for Service and Learning.
- ⌘ Should be submitted electronically.
- ⌘ Describe and give dates of program/event for which you are requesting funding.
- ⌘ Explain why this funding source is appropriate for this program/event.
- ⌘ Outline of the budget for the program or event (if applicable) and amount of funding requested.
- ⌘ Document additional funding sources if request is for one-time presentation or event. If event or presentation is sponsored by another campus department, program or office, documentation of their funding is required.
- ⌘ Plan and timeline for securing permanent funding if request is for new initiatives.
- ⌘ Acknowledge the Center for Service and Learning Special Projects Fund in all publicity.
- ⌘ Include the Center for Service and Learning in the distribution of the publicity associated with the funding request.



CCSGA Funding Options

Funding for One Time Events:

A person or group seeking funds from CCSGA must fill out a funding request form from Campus Activities. They should also contact the current CCSGA Financial Vice-President.

CCSGA has funds available for one-time events and new service organizations. For more information, go to www.ColoradoCollege.edu/students/CCCA

To Secure Ongoing Funding:

CCSGA Recognition and Chartering:

- ⌘ Ongoing Service organizations can apply for CCSGA recognition after one semester of activity.
- ⌘ Ongoing service organizations can apply for CCSGA chartering after one-year of being recognized.
- ⌘ Being CCSGA chartered allows a student organization to apply for a CCSGA budget.
- ⌘ The application process for CCSGA recognition/chartering occurs once a semester, once in Block II and once in Block VII.
- ⌘ Applications for CCSGA chartered organization budgets occur during Block VII for the following academic year.
