#### 2019 Student Experience Survey Results

Developed as a result of a 2015-16 Faculty and Staff Taskforce which reviewed the 2014 Gallup-Purdue Index (the largest representative student of college graduates in U.S. history) which sought to measure outcomes that better reflect the variety of reasons individuals choose to attend college. The index's results "provides insight into the relationship between the college experience and whether college graduates have great jobs and great lives." Taskforce identified nine (later increased to 10) student experiences at CC that all student should experience or have an opportunity to experience. The survey was first conduced in January 2016 and has been annually administered by the Office of Institutional Planning & Effectiveness
