Spring 2018 Reminders for International Students

Happy New Year and welcome back to campus! As we begin a new semester please remember these important tips below:

⇒ **Please complete your “term check in” in Self-Service Banner**
As you know, in order to maintain your F-1 student status, you are required to keep a current residential address on record at all times. The Self-Service Banner (SSB) address used for reporting your U.S. address to SEVIS is the address type of “Residence Hall” for students living on-campus and the address type of “Temporary/Local” for students living off-campus, not any of the other address types available in Banner (such as Mailing/Home, etc.)
Note: Your Temporary/Local address cannot be a post office box, foreign address, or Worner box campus address. No other check-in is required at the Office of International Programs (OIP).



⇒ **Check your documents!**
Anytime you travel, it is recommended that you print out your newest I-94 (Arrival/Departure Record) from the U.S. Customs and Border Protection (CBP) website at www.cbp.gov/i94. Ensure that you were admitted in the correct status (F-1/J-1). Please be sure to review your documents regularly. Is all the information correct? Have you changed your name, country of citizenship, major, source of funding, or program end date? Is your passport valid at least six months in the future? Is your visa stamp expired? If any information has changed, please visit the OIP office during our drop-in advising hours for assistance. Also, if you obtained a new passport or a new F-1/J-1 visa stamp in your passport during Winter Break, please bring your new document to the OIP office so that we can make a photocopy of it for our records.

⇒ **Reminder to maintain full-time enrollment status**
Students holding F-1/J-1 status are required to be registered full-time (at least 3.0 credits/12 semester hours, not including any waiting lists) each semester. You must be fully enrolled (not including any waitlisted classes) by **Thursday, February 22nd**. A reduced course load can be authorized by the OIP office only in limited circumstances. Approval must be obtained prior to dropping below a full-time course load. Contact the OIP office for more information.

⇒ **Spring Semester Tuition payment due February 1, 2018**
Review your student account charges through your online billing account and prepare to pay your billing invoice by the required deadline. If you have questions or concerns about your invoice, or if you would like to

Beware of Tuition Payment Scams

As an international student, there are many unique challenges to overcome as you prepare for your education abroad. Unfortunately, this can include being the target of scammers who attempt to steal your tuition and educational payments for themselves—in indirect and subtle ways. Schools have reported an increase in unauthorized, non-school approved tuition payment companies (or individuals) stealing entire tuition payments from their students in the recent weeks. These scammers may even claim to have an affiliation with your school. They might offer you a tuition discount, currency exchange discounts, or make other promises in an attempt to confuse you before you are fully aware of your school’s official payment process.

To avoid the risk of fraud, follow these best practices when making your tuition payment:

- **Take online security precautions**
If you’re paying your school online, make sure the website is secure. The address of any site you may use to share personal or financial information should begin with https (for example, <https://www.flywire.com>), which

Finishing Your Program of Study at CC in May 2018?

F-1 students who have maintained lawful status have a 60-day “grace period” following their program end date at CC to:

- **Depart the U.S.;**
- **Request a transfer of their SEVIS record to another school to begin a new program of study; or**
- **Apply for a change of nonimmigrant status**

ensures the data you provide is protected through encryption. Additionally, avoid using public or unsecured Wi-Fi when sharing sensitive information. If you get an email from a suspected scammer, NEVER click on any hyperlinks.

- **Always verify who you're speaking to**

Scammers may pose as a government agent and threaten to revoke your visa unless you send a payment to them immediately. They may also request your personal information—which you should never disclose until you have verified that the requestor is an actual government agent authorized to do so. If you receive any communications from a person posing as an IRS or government agent, your first step is to research whether their requests are valid.

- **Don't share your information**

Credit card information, personal information (i.e., name, date of birth), and banking details should never be handed out to anyone without a contract or relationship with your university, and payment enablers that aren't verified as authorized by your university should be ignored. These scammers may claim to have relationships with universities and colleges that don't exist, show "official" documents with artificial co-branded school logos, etc. Be careful of anyone that is asking you to provide sensitive information, as university officials should already know most of your details. This person may be fishing for your information to use fraudulently. As a best practice, always confirm with your university whether or not a payment processor is affiliated with them. It may help to check the school payment website (e.g., by reviewing the payment portal and reviewing the "how to pay" section) to verify as an initial step.

- **Be wary of aggressive, suspicious characters**

Is someone promising you a discount on your payment or volunteering to pay on your behalf? Be careful! If the offer seems too good to be true, then it probably is. If you take them up on their offer and share your personal, banking, or financial information, entrusting them to pay on your behalf, you run the risk of losing your payment in full and set yourself up for further fraud risks later on. Fraudsters are very calculating in selecting their methods of introduction to international students—you could be approached on-campus, in a student visa application queue, or at an event for admitted students and their families in your home country.

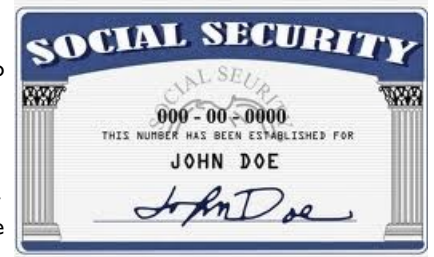
- **Report suspicious activity**

If you suspect you are being targeted for fraud, you should note the information the scammer is attempting to get from you, stop communicating with them immediately, and report this to your university as well as the police. Remember that your university's trusted website and administrators can help you verify the approved payment process or the identity of someone requesting money or information from you. Don't start your university experience off on the wrong foot—be smart and be safe!

Responding to SSN/ITIN Requests from Health Insurance Providers

Have you recently received a letter from the CC-sponsored student health insurance plan, United Healthcare (UHC), asking for you to provide your U.S. Social Security Number (SSN) or Individual Taxpayer Identification Number (ITIN)? As of 2015, health insurance providers in the U.S. are required to collect this information from their members in order to comply with Internal Revenue Service (IRS) reporting requirements related to the "individual shared responsibility provision" of the Affordable Care Act (ACA). Since health insurance providers don't know whether their members are resident aliens or nonresident aliens for U.S. tax purposes, and since, under the Affordable Care Act, health insurance providers must report on the minimum essential coverage they provide for all covered individuals, that is why health insurers now contact their members to collect the insured person's tax identification number, if the health insurer doesn't already have this information on file. These insurers must then confirm—during every tax season—that the coverage provided to the member satisfied the individual mandate requirements for any or all months during the preceding calendar year or reportable tax year.



The IRS requires that the tax identification number, which is usually the Social Security Number (SSN) or Individual Taxpayer Identification Number (ITIN), be used to identify individuals on IRS reports. Since, as noted earlier, insurers may not always have this information, the rules require that insurers make reasonable efforts to obtain the SSN or ITIN. The rules further state that the reasonable efforts mean asking for SSNs/ITINs up to three times before any annual filings. Therefore, if you do not respond to the initial request from UHC or another health insurance provider for your SSN/ITIN, expect that you will receive up to two more requests for this information.

So, if you already have an SSN or ITIN, the easiest thing to do is to report it to your health insurance provider when first asked. If you do not have a Social Security Number and are not currently eligible to apply for one because you do not have an on-campus employment offer or you do not have off-campus employment authorization, then you may be able to apply to the IRS for an Individual Taxpayer Identification Number (ITIN)—please see the Office of International Programs for further information and assistance.

⇒ Update your Glacier Tax Record

With tax season upon us, please take a moment to login to your [Glacier](#) account to review your individual record and ensure the information is up to date and accurate. Contact information, employment information, and social security information must all be updated if your employment status has changed since you created your Glacier account.

Make sure you carry the proper immigration documents with you when you travel, both within the U.S. and internationally!

Documents Needed for F-1 Travel

- Valid passport
- Valid U.S. visa stamp (Canadians are exempt)
- Valid Form I-20, signed for travel on Page 2 within the last 6 months
- Evidence of financial funding (bring a copy of whatever funding is mentioned on your Form I-20: bank statement(s)/ sponsorship letter(s), CC Financial Aid letter, etc.)
- Proof of enrollment (print out of course schedule or transcript.)
