 - President Tiefenthaler reported on the outreach to date, including the four community listening sessions. The program subcommittees will continue their outreach through the end of the month.
 - The program subcommittees shared their emerging themes with the SPC earlier in the day. A summary of those themes and the thematic summaries of the four listening sessions will be posted to the website the first week of November. Administrative Transition update:

- A full review of the facility has been completed by an independent company. The report found over \$7.5M of deferred maintenance. The agreement calls for the college to spend \$500K on the facility. At present the list of priority items total over \$527K. The detailed list of priorities will be shared with the committee at the November 4th meeting.
- The FAC employees within the museum program have all been transitioned to the college and are now employees of the college. An FAC Ops working group has been formed and charged with developing a plan for the remaining transitions, including the functions of IT, security, facility maintenance, HR, finance, etc.; as well as the remaining employees.
